## **Overall Status/ Development of logistics & venue arrangement for 15th AOSSG Annual Meeting**

The 15<sup>th</sup> AOSSG Annual Meeting will be hosted by Australian Accounting Standards Board (AASB) from 20 - 22 November 2023 with all delegates to attend in person.

In addition, AASB extended an invitation to all AOSSG members to attend a National Standards Setters Symposium Forum on Sustainability Reporting to be held in person on 23 – 24 November and the AASB Research Forum scheduled for 24 November 2023. Registration will be free for all attendees of the AOSSG Meeting.

The venue for the AOSSG 15<sup>th</sup> Annual Meeting has been confirmed as The Westin Hotel, 111 Mary Street, Brisbane, Queensland, Australia.

Registration details have been provided to AOSSG Members via the AOSSG Secretariat. The Link provides AOSSG Members with the registration details to the various meetings and events.

Accommodation options are included as part of the registration. Room options have been provided for The Westin, The Four Points by Sheraton and the Ibis Styles Brisbane.
